5. You may bring a shade awning and additional tables and chairs and/or children's tables.
6. Exhibitors are allowed to bring their lunch.
7. No selling of merchandise or other items, including food items.
8. Exhibitors are welcomed to have their own individual prize drawings at their booths.
9. Check-in will be at the main entrance. Please sign-in and pick up your information packet.
10. This year's theme is "Once Upon A Time", all booths should be covered and decorated festively utilizing the "Once Upon A Time" theme. Please join in on the fun
11. Please avoid glitter and confetti as it is hard for the clean up.
12. Prizes will be given to best decorated booths (more than one winner will be chosen).
